### **BOOKINGS**

#### **1. General**

These conditions apply whatever the purchaser's general purchasing conditions may be. Any departure from these conditions, stipulated in the order, will only be considered as accepted once our written consent has been accorded. The order is considered as final only after our acknowledgement of the order.

#### **2. Subject and Limit of the Offer**

The conditions of this offer apply exclusively to the supply of services specified herein, and are not binding for additional services. The purchaser in no case will be allowed to put forward standards, specifications, statutes, rules and uses not duly accepted by our company.

#### **3. Validity**

Unless otherwise specified, our offer is open for acceptance within 30 days from the date of which it is established, after this date it is invalid.

### **TERMS AND CONDITIONS**

4. Charges start from when the vehicle leaves our base and finish at the time of its return.
5. All bookings are subject to availability at the time of the reservation. For operational reasons our company reserves the right to substitute vehicles of similar category of capacity, where necessary.
6. Astra reserves the right to cancel bookings, amend fares, itineraries, days and times of operation of services offered without notice. The purchaser is responsible for confirming availability.
7. Booking costs do not include meals, entrance fees, mobile phone usage, airport ground service charges, accommodation, venue costs or other incidentals unless specified. Otherwise these will be added to the booking cost on a per person basis where applicable. Surcharges may apply to Special Events, Public Holidays and between 12.00 midnight and 05.00 am.
